launch the European Mutual Insurance Award**

Brussels, 7 December 2016 - AMICE (Association of Mutual Insurers and Insurance Cooperatives in Europe), Lieve Lowet, partner of ICODA European Affairs and (mutual) insurance expert, and UAAM-VVOV, Union des Association d'Assurance Mutuelle/Verbond der Verenigingen van Onderlinge Verzekering, which represents the Belgian mutual and cooperative insurance undertakings and groups, **have launched a new biennial European Mutual Insurance Award today**, encouraging younger members of the industry and academia to pursue research on the mutual and cooperative insurance model

A prize of 2500 euro will be granted every two years to a research paper of academic quality that makes a significant and original contribution to the study of the organisation of mutual and cooperative insurance.

The topic of the first award is the treatment of mutual insurers under Solvency II. The subject can be treated from a European perspective, or from that of an EEA or equivalent jurisdiction. Deadline for submissions is 15 January 2018.

The Award will be announced and presented at AMICE's biennial congress, to take place in Stockholm in, June 2018, to which the winner will be invited.
